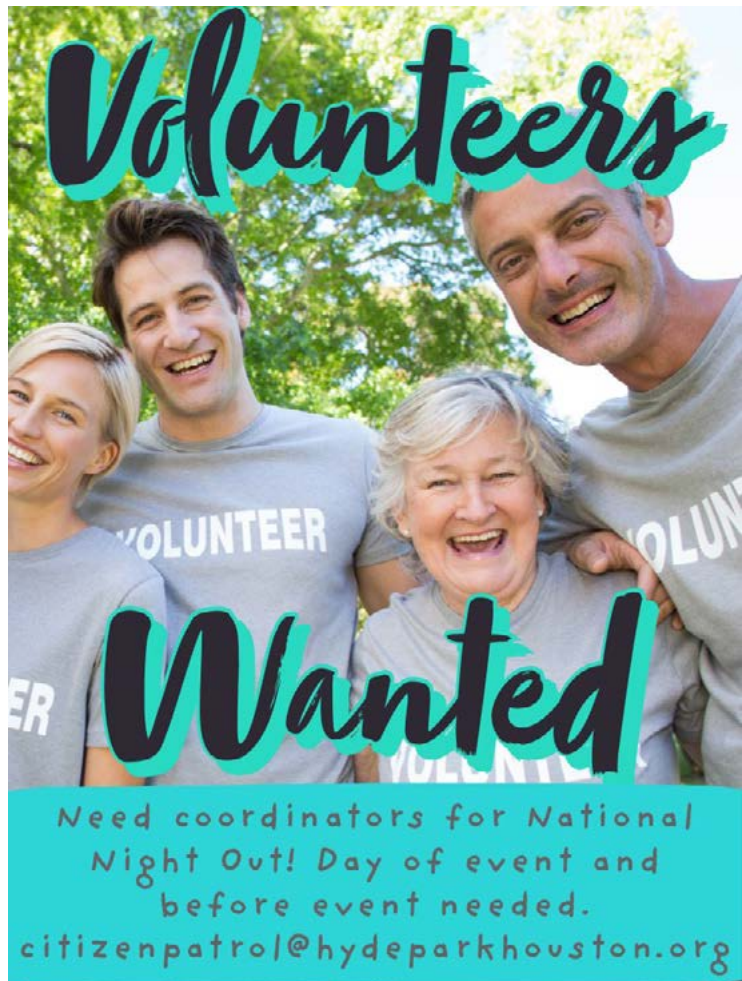
VOLUNTEERS AND BOARD VACANCIES

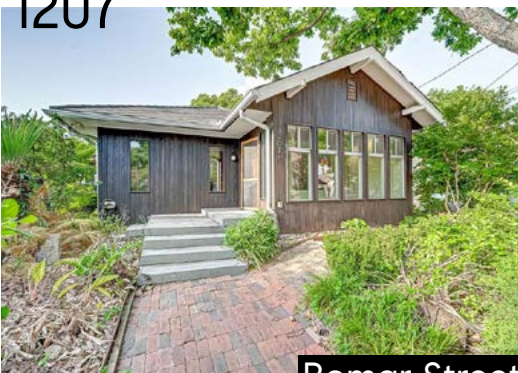

Honoring Juneteenth?

Quick Facts

#1 Following the issuing of the Emancipation Proclamation on January 1, 1863, not all enslaved people immediately found freedom.

The Emancipation Proclamation freed slaves in states then in rebellion against the United States. Union troops operating in said states gave teeth to the Proclamation. This, however, did not apply to the border states.

#2 The Civil War ended in the summer of 1865. Union General Gordon Granger and his troops traveled to Galveston, Texas to announce General Orders No. 3 on June 19, 1865. June 19th would go on to be known and celebrated as Juneteenth.

General Orders No. 3 stated: "The people of Texas are informed that, in accordance with a proclamation from the Executive of the United States, all slaves are free. This involves an absolute equality of personal rights and rights of property between former masters and slaves, and the connection heretofore existing between them becomes that between employer and hired labor." Fact #3: Part of General Order No. 3 encouraged the newly freed people to remain with their past owners.

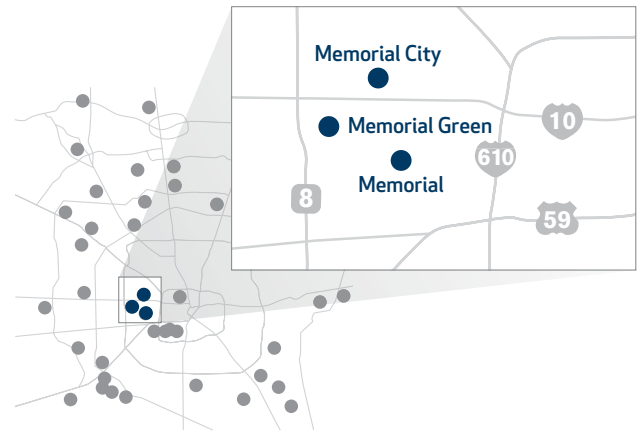

Juneteenth Facts, *Continued*

#3 The period after Juneteenth is known as the ‘Scatter.’

Undeterred by the recommendation to remain in place, many former slaves left the area during the original reading. In the following weeks formerly enslaved people left Texas in great numbers to find family members and make their way in the postbellum United States.

#4 Emancipation Park in Houston was bought specifically to celebrate Juneteenth.

The 10-acre parcel of land was purchased by former slaves, Richard Allen, Richard Brock, Jack Yates, and Elias Dibble for \$800 in 1872.

#5 On June 17, 2021, President Biden signed the Juneteenth National Independence Day Act, which officially made Juneteenth a federal holiday.

This holiday is the first holiday to be approved since President Ronald Reagan signed a 1983 bill that approved Martin Luther King Jr. Day as a federal holiday.
