



Plans are underway for improvements at Lamar Park and The Dolphin Fountain!

Board members voted earlier in the year to approve funding for two projects that will serve to add value and enjoyment to the community.

In Lamar Park, subtle down-lighting will be added throughout the walkway path.

Long overdue, this enhancement will provide an added layer of security for those passing through at nighttime as well as a deterrent to those who wish to congregate hidden in the dark for long periods of time, as the park hours are dawn to dusk.


At the Dolphin Fountain, a renovation will take place to utilize the fountain as a beautiful planter for shrubbery and flowers for all to enjoy.
