# February HPCA Meeting Recap

The meeting was called to order at 7:00 by **President Chris Delphin**. We had a good crowd of about 35 people for this meeting. Speakers have been lined up for March-a representative from the census will come and speak to us. In April we hope to have **Abby Kamin**, the new representative for District C.

Chris mentioned that we are still in need of volunteers. Positions that are currently open are Vice President, Treasurer, Volunteer Co-Ordinator, and block captains. We would love to see you join our group and help out Hyde Park.

Reports followed-

**Deed Restrictions**- The committee is waiting to hear a response from the owner of the AirBnB. A cease and desist letter was sent to him on January 25.

Townhomes on Jackson are being built and there is a question about the setback line for the carport. The architect has been contacted and is not returning calls.

**Lamar Park**- The new committee chair, **Melissa Zarikian**, has received all the information from the previous chair person. She is becoming familiar with all she has to do. She will look into getting TIRZ to help with the fountain and lighting for the park. She will talk to **Courtney Sellers** about grant writing.

**Membership**- we now have 51 members. The next Happy Hour will be February 19th at 5:30 at Bar 006 which is downstairs from Rosemont and owned by a Hyde Park resident. Complimentary cocktail and free bites will be offered.

**Clean-Up**- Neighborhood clean-up is set for March 28. We will meet at the **Whitworths'** house at 9:00 and work until about 11. After all the work, we will meet somewhere for drinks and lunch.

**Treasurer**- We currently have \$9,673.74 in our Treasury.

We had several people or representatives of people running for elections. **Ann Johnson** is running for State Rep. District 134. Early voting starts February 18. Representatives for **Mike Bloomberg** were present as was a representative from **Sarah Davis'** office. He said he would also like to be considered as a resource to contact with any neighborhood problems.

The meeting was adjourned at 8:10.



## Speaker Recap - Sherry Weesner

The Speaker for our February 4th Civic Club meeting was **Sherry Weesner**, a board member of TIRZ 27. **Patti Joiner** assisted with the presentation. Ms Weesner began by explaining what TIRZ is. Tax Increment Reinvestment Zones (TIRZ) are special zones created by City council to attract new investment in an area. Zone 27 is the area that includes Hyde Park. Currently there is \$2.5 million in the TIRZ 27 account. The type of projects that can be financed are Capital Projects which include streets, drainage, water, parks and public facilities, streetscape (sidewalks, lighting, landscaping), parking facilities, affordable housing and economic development.

The goals of TIRZ are:

- to enhance parking opportunities and the associated pedestrian friendly environment
- stimulate economic development and growth through the development of vacant sites and redevelopment of older areas
- develop and enhance open space within the zone
- facilitate development and redevelopment of affordable housing in the zone
- enhance the Montrose transportation network and promote mode choice

There are several financing options:

- Pay-as-you-go after building up a bank of increment funding
- Bond financing-TIRZ's can issue bonds using increment projections as collateral
- Development Agreement- allow developers to advance finance the infrastructure projects surrounding their development and then receive reimbursement by that project

The development agreement was used at the future library. Extra parking spaces and special lighting will be part of the project.

One interesting study recently done was a sidewalk study of Montrose. Every sidewalk in Montrose was walked to discover the shape of them. It was found that 70% of them were passable. This was quite surprising to the audience. Our TIRZ is in the design phase of Waugh and Commonwealth and Westheimer. They are trying to improve safety within the next 5 years. It was mentioned that a letter regarding traffic safety in that area had already been written and submitted to the Department of Public Works/Traffic Management Branch. Ms Weesner asked that the letter be forwarded to her. This was promptly done. Ms Weesner suggested that the Dolphin Fountain could possibly go on the potential project list. It was suggested to write grants concerning the fountain and Courtney Sellers volunteered to help with that.

## What can we do to help?

Pay attention to projects that need to be done and let the TIRZ Board know about them. Also tell neighbors about TIRZ.

We thank Sherry Weesner and Patti Joiner for giving such an informative presentation on TIRZ. There are many websites you can go to for more information about our TIRZ. One such site is: <https://montrosehtx.org>. The Board meets every 3rd Monday at St. Stephen's Church and all are welcome.




